



**THE CORPORATION OF THE TOWN OF GODERICH
BY-LAW NO. 116 OF 2018**

**BEING A BY-LAW TO AMEND BY-LAW 85 OF 2016, A BY-LAW TO
REGULATE TRAFFIC IN THE NORTH HARBOUR AREA AS DEFINED
HEREIN AND TO CONTROL AND REGULATE THE USE
OF STREETS AND BOULEVARDS IN THE SAID AREA**

WHEREAS Section 11, of the Municipal Act, 2001, S.O. 2001, c.25 and the provisions of the Highway Traffic Act, R.S.O. 1990, H.8, as amended authorize a Municipal Council to pass by-laws to regulate and control traffic;

AND WHEREAS Council of the Town of Goderich passed By-Law 85 of 2016 at their regular meeting of August 8, 2016;

AND WHEREAS By-Law 85 of 2016 is a by-law regulating traffic, parking and the use of streets in the North Harbour area;

AND WHEREAS Council finds is necessary to amend Part V, Subsection 4 a) of the by-law pertaining to the six-hour time restricted parking;

AND WHEREAS it is desirable to amend a & b of Schedule 2 pertaining to the Time Restricted Parking to reflect a 3 hour time restricted parking limit.

AND WHEREAS it is deemed expedient to include a parking regulation under Schedule 2 for the parking area which extends 53 M southerly from the south side of North Harbour Road and 5 M from the westerly lot lone of 111 North Harbour Road and ending at the easterly limit of the Goderich Harbour.

AND WHEREAS the provisions of Part V will apply to the areas as described in Schedule 2.

AND WHEREAS Council wishes to amend By-Law 85 of 2016 accordingly;

NOW THEREFORE, THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWN OF GODERICH ENACTS AS FOLLOWS:

1. That Schedule 2 be amended as follows:

TIME RESTRICTED PARKING

b) North Harbour Rd.	North Side	Parking area which extends	Parking reserved

Easterly a distance of 115M and westerly a distance of 100 m both measured from the most easterly projection of the commemorative rock at the trail entrance reserved for users of the Menesetung Bridge and Trail

for those using Menesetung Bridge and Trail – 3 hour limit

ADD

<u>COLUMN 1 STREET</u>	<u>COLUMN 2 SIDE(S)</u>	<u>COLUMN 3 FROM-TO</u>	<u>COLUMN 4 TIME OR DAYS</u>
c) North Harbour Rd	South Side	Parking area which extends 53 M southerly limit from the south side of North Harbour Road and 5 M from the westerly lot line of 111 North Harbour Road and ending at the easterly limit of the Goderich Harbour	Everyday 3 hour limit

2. That By-Law 85 of 2016 be hereby amended.

3. That the Mayor and Clerk are hereby authorized to execute and affix the Corporate Seal.
