

**THE CORPORATION OF THE TOWN OF GODERICH**  
**TAXI DRIVER'S LICENSE APPLICATION**  
**APPLICANT ELIGIBILITY**

"*Taxi Driver's License*" means a license issued under the authority of this by-law to a person for the operation of a taxicab, shuttle vehicle and a limousine.

**An applicant for a holder of a taxi driver's license shall meet the following requirements:**

1. Have reached the age of nineteen (19) years
2. Holder of a valid Ontario driver's license issued by the Province of Ontario designated a Class "G" (not a G1 or G2 or be classed as a probationary driver).
3. The applicant shall not have accumulated more than four (4) demerit points in his or her driving record at the time of application.
4. The person shall not have been convicted or found guilty within the preceding twelve months of an offence under the *Highway Traffic Act* in regards to moving violations.
5. The person shall not have been convicted or found guilty within the preceding three (3) years of more than two (2) offences committed on different dates under the *Highway Traffic Act* in regards to moving violations.
6. The applicant shall not have been convicted or found guilty within the preceding five (5) years of an offence under the *Criminal Code* (Canada) or of the *Narcotics Control Act* (Canada) or *Controlled Drugs and Substances Act*.
7. The applicant shall not have been convicted or found guilty within the preceding ten (10) years of more than two (2) offences under the *Criminal Code* (Canada), *Narcotics Control Act* (Canada), *Controlled Drugs and Substances Act*.
8. An applicant for a taxi driver's licence must not have been convicted or found guilty of an offence for conduct against minors or that in the opinion of the Clerk affords reasonable grounds for believing that the person will not properly perform his or her duties with passengers under the legal age (minors) while having control of a taxi.
9. The applicant shall not have been convicted or found guilty of an offence under the *Liquor Licence Act* of Ontario pertaining to the illegal sale or purchase of liquor within the preceding three years.
